Re: **Signing a Cooperation Agreement with Eldan Cargo 2000 Ltd.**
A Member of the E.T.G.A. Group

Following the Company's announcement dated November 17, 2021 (reference number 2021-01-098647) regarding the signing of a Letter of Intent between the Company and Eldan Cargo 2000 Ltd. (hereinafter: '**Eldan Cargo**'), regarding cooperation between the Company and Eldan Cargo, the Company is hereby honored to report that on January 3rd, 2022 a Cooperation Agreement was signed between the Parties (hereinafter: the '**Agreement**') whose principal points are as follows:

1. The Parties will work in collaboration for the integration and implementation of the Company's platform (hereinafter: '**Trucknet Platform**') in Eldan Cargo's systems (hereinafter: the '**Integration Process**') for an estimated period of 90 days, by the Parties, from the date of the Agreement.
2. Following completion of the Integration Process the Company shall grant Eldan Cargo with a license to use the Trucknet Platform for the duration of 30 days, without consideration (hereinafter: the '**Trial Period**'). At the end of the Trial Period, Eldan Cargo will pay the Company a total of 5 Euros for each planned trip via the Trucknet Platform. Furthermore, for each Smart Match executed via the automatic Smart Match system on the Trucknet Platform, Eldan Cargo will pay an additional amount to the Company at the rate of 5% of the haulage price of each such match, which will be charged to sub-contractors who are registered in the Company's system. The terms of payment will be agreed and determined between the Parties prior to the commencement of commercial use of the Trucknet Platform by Eldan Cargo.



3. In so far as the Agreement is in force, Eldan Cargo may initially operate the Trucknet Platform in Israel, at its discretion, for a period of three years (unless the Agreement terminates earlier), and, subject to agreement of the Parties, Eldan Cargo will extend its use of the Trucknet Platform for the duration of an additional three years throughout the European Union and the United States.
4. The Agreement is for an indefinite period and each Party shall be entitled to terminate the Agreement by 30-day prior notice to the other Party.

The information provided above regarding the cooperation with Eldan Cargo is, to the best of the Company's knowledge, based on the data they have on hand and without these being verified independently by the Company. Furthermore, the Company cannot, at this stage, estimate the expected scope of use of the Trucknet platform by Eldan Cargo.
